Al has been in contact with the Arapahoe County Zoning Department concerning the unsightly condition of the Bramante fence facing Saxony's west side. The County will be addressing the matter and will update Al with the progress. The drainage easement owned by Huntington Pines HOA (30.4 feet wide) separates Saxony and Bramante. Saxony has an unrecorded Agreement with Huntington Pines to maintain and enjoy the use of the surface of the easement. This Agreement carries absolutely no responsibility to Saxony for the fence in any way.

Dave Littler recently got competitive bids for our landscaping services and the Ground Masters contract for 2012 was approved and signed. Bids will also be solicited to procure an updated Reserve Study for Saxony and should be completed during this calendar year.
