There have been inquiries as to why the sprinklers continue to run even when we have had rain. The new timer control system runs on a 24 hour cycle and adjusts only once in that time period; usually at midnight. The sensor reads the temperature, humidity, rain, and amount of sunlight etc., which then triggers adjustment of the running time up or down depending on the conditions. As a general rule, the system will not actually shut itself down during rainy days, but does adjust the running times. Thank you for your inquiries, we know it can be confusing and hope this offers a reasonable explanation.

The Board has just accepted a bid from PLM to do some concrete replacement and repairs. The work is anticipated to be commenced in October. There will be further information and a notice at the mail kiosk when the actual date is confirmed. Many residents have asked about contracting individually to do their driveways or entry walks at the same time. If you are interested, please contact PLM Asphalt & Concrete, Inc. 303-287-0777 and mention that you live in Saxony and would like to coordinate with the HOA scheduled job. You will be billed separately as this would not be an HOA expense. Our contact person is Dusty Heuchert. The Board and Management cannot recommend any particular company, nor do we guarantee their work. For that reason, we would strongly suggest that you get at least one other bid and check references and ratings for any company you may contract with, including PLM.

We will keep you informed of any progress.
