With 90+ degree days for a week, Summer has definitely arrived. Therefore....

Bloom Floralscapes ("Bloom") has planted annuals on the usual corners, has activated Saxony's sprinklers for normal Summer watering and has begun weekly mowing and bi-weekly trimming. Our regular mowing day will generally be Friday (not Monday, as previously reported), weather and holidays permitting. Some replacement grass is scheduled to be planted on June 18. Some shrub trimming and removal has yet to be scheduled.

Saxony South. The stucco wall power-washing, repairs and painting on the Caley side were completed this month.

Several homeowners have noted the unkempt appearance of the Caley medians. Arapahoe County is responsible for upkeep of the medians. Authorities have been notified and asked to attend to them.

Saxony West. The Board and several homeowners have also notified Arapahoe County authorities regarding the west-side fences. Each Bramante homeowner is responsible for upkeep of their fence. Several owners have made the necessary repairs and repainting; several have not. Arapahoe County zoning officers have again contacted the Bramante manager and have threatened sanctions if the owners do not comply. It is expected that repairs will be completed this Summer.

Saxony North. In accordance with the agreement with Huntington Pines, Fielding Trees has cut back the spruces on Saxony's side and the locusts on Huntington Pines property. Some more trimming may be necessary.

A bid from Omega Contracting has been approved to repair, replace and restain broken portions of fence and support posts between Saxony and Huntington Pines. This should be completed this month. The two associations are sharing equally in the cost of both projects.

The board reviewed the Saxony Reserve Analysis, which was professionally updated in 2012.
