Bloom Floralscapes ("Bloom") completed planting some replacement grass on June 18, as well as replacing some annual flowers that didn't take hold. Bloom has also done most of the summer shrub trimming. Mulch for the flower beds should be installed this coming week. Because of subsidence, some fill dirt needs to be added to several lots. Bloom also has been asked to submit suggestions for several additional small improvement projects.

Sprinklers should now be properly set to operate automatically for watering time and coverage. The known sprinkler problems have been fixed. If you still have a problem, please contact Saxony Manager, Dave Littler. For your information, the sprinklers will not turn on if it is raining more than a sprinkle. If the sprinklers are already on, according to the schedule, and it starts to rain, they will not turn off.

Fielding Trees is contracted to spray the neighborhood apple trees when appropriate.

Fielding has completed the tree trimming along the northern boundary with Huntington Pines. Omega Contracting completed the repair, replacement and restaining of broken portions of fence and support posts between Saxony and Huntington Pines. The two neighborhood associations shared equally in the cost of both projects.

The Caley medians still need attention.. Arapahoe County authorities have been notified again and asked to attend to them.

The state of the Bramante fence to the west of Saxony is a continuing problem. Several Saxony homeowners on the west end have taken the lead in pressuring the Bramante homeowners association and Arapahoe County to repair and repaint the remaining problem fences.

The Saxony Reserve Analysis is under professional review.
