STREET REPAIRS. Andreos Construction is scheduled to begin concrete repairs on **October 15**, weather permitting. Sections to be removed and repaved are now outlined in yellow paint. Work will likely take about four days and will begin on the east side of the neighborhood, working toward the west. Traffic patterns and parking in Saxony will be affected. Please be aware of the section closures and the construction equipment. Some residents may not have access, or have only partial access, to their driveways for a couple of days (note the yellow lines). Affected homeowners will be directly notified of the schedule and street area closures. Plan to park as far away as possible from the area being worked on. Trash collection and recycling may also be affected. Some residents may have to take their bins to a different spot to ensure pick-up, probably near the entrance. Please keep your eye on your email and the mail kiosk bulletin board for updates.

Summer landscape maintenance issues are winding down. However, this past week Bloom Floralscapes ("Bloom") followed up on some problem weed areas, did some rock replacement and

planted new shrubs for a homeowner. The sprinklers will likely be turned off around the end of October.

That means it is time to worry about snow removal. The Board approved a contract with Bloom for the coming winter season. A walk-through will be scheduled with Bloom to place the snow stakes, indicating the limits for snow plowing, and to confirm where snow must be stored.

Fielding Tree is scheduled for a walk-through on October 3 to identify the trees that will be trimmed when they turn dormant.

The Board has evaluated the feasibility of various options that might improve security in the
