Bloom also completed the installation of rock in various bare spots around the neighborhood.

The sprinklers have recently been turned off and blown out due to decreasing temputures. We have some new grass in areas throughout the community. If you have these areas around your home, we encourage you to hand water these areas to ensure that they remain healthy and come back strong in the spring.

The stucco surface continues to be an issue on the inside and outside of the East exterior wall of the neighborhood. The wall is structurally sound, but water seeps into the top of the wall and damages the stucco surface. This is potentially a very expensive fix and we are getting a number of opinions and bids to make the repairs. This will most likely be a spring project at this point. We will keep you posted on the progress.

As a reminder, Dennis Bierschback has been serving the neighborhood for 9 years. His term is up in November and he has indicated that it is time for someone else to take his place. Very big shoes to fill, but no doubt one of you will have fun trying. Please let us know if you are interested.
